Isolate (COVID +)	Followed CDC guidance. Home for 10 days, then reduced mid-year to 5 days (wore a mask days 6-10).	COVID positive individuals must isolate at home for 5 days. 		*If they become symptomatic, they must stay home 5 days from the onset of symptoms and may return on day 6 as long as fever-free and symptoms have improved. No mask required on days 6-10. This will only apply when we have been notified by DPH that an individual is on quarantine.
Athlete Questionnaire	Parents were required to complete a student athlete questionnaire after a COVID + illness.	No athletic questionnaires will be required. If a student is hospitalized, School Leaders/Coaches must require a healthcare provider note that clears the students to play, regardless of diagnosis, before they can return to practice/competition.
Blended Learning Groups	Students that opted for the CDC defined quarantine participated in Blended Learning Groups.	Quarantines are no longer required within the HCSD. If the family chooses a CDC defined quarantine (after an exposure outside of school), the family is encouraged to work directly with the
		If student has a high absence rate, a note from a healthcare provider or public health official may be requested from the family.
Reports to DPH	Daily reports sent to DPH. State reports sent on Fridays (was discontinued in the Spring per the state).	Daily reports of COVID positive cases will be sent to the local DPH.
Hospitalized Employees/Students	Required a note from the doctor with a return date.	Require a note from the doctor with a return date. The hospitalized email template will be sent by the nurse or designated staff person to the employee.
