

## Hall County School District Enrollment Requirements

To enroll your child as a kindergartner or a new student to the HCSD, please go to [www.Hallco.org](http://www.Hallco.org) and choose enrollments to register online, or visit the school in the attendance zone where your family resides.

The parent/guardian must complete the [Student Registration Form](#) and must present the following **seven documents** to the school. All utility bills must be from the **last 30 days**.

*In order to be enrolled, children entering kindergarten must be **five (5) years of age on or before September 1.***

<b>Document #1</b>  <input type="checkbox"/>	<p><b>Proof of Residency #1: In Your Name...</b> Share your current mortgage statement, deed, or property tax statement <b>OR</b> a current lease/rental agreement <b>OR</b> a current non-contingent sales contract in your name.</p>	<p><b>Proof of Residency #1: In A Different Owner or Landlord's Name...</b> Complete a Hall County School District Residency Affidavit <b>OR</b> share a deed, or property tax statement <b>OR</b> a current lease/rental agreement <b>OR</b> a current non-contingent sales contract in your name.</p>
<b>Document #2</b>  <input type="checkbox"/>	<p><b>Proof of Residency #2:</b> Provide a current utility bill to include gas, electric, water, cable/satellite/internet or garbage pickup that provides your service address <b>OR</b> a current income tax return; paycheck stub; homeowner's or renter's insurance policy; other official government correspondence.</p>	<p><b>Proof of Residency #2:</b> If you are using a residency affidavit, you may provide any of the documents listed to the left in either your name or in the name of the homeowner that signed the residency affidavit.</p>
<b>Document #3</b>  <input type="checkbox"/>	<p><b>Guardian Photo ID:</b> The parent or guardian must be present in order to enroll student(s) and must present photo identification and verify guardianship.</p>	
<b>Document #4</b>  <input type="checkbox"/>	<p><b>Georgia Immunization Certificate Form 3231, Rev. 7-2014.:</b> Parents must present the Georgia Immunization Certificate at pre-registration. A current Georgia Immunization Certificate Form 3231 (marked complete for school or incomplete with an expiration date of no more than 30 days). After 30 days of school attendance, a student without a current Form 3231 on file will be unenrolled. For families requesting a religious exemption for immunizations, please see additional information <a href="#">here</a>. Religious exemptions must be notarized on <a href="#">Form 2208</a>.</p>	
<b>Document #5</b>  <input type="checkbox"/>	<p><b>Certificate of Vision, Hearing, Dental, and Nutritional Screening Form 3300, Rev. 2013:</b> is required upon entering school. Services for Form 3231 and for Form 3300 are available from the: Hall County Health Department – 1290 Athens St. (770) 531-5600.</p>	
<b>Document #6</b>  <input type="checkbox"/>	<p><b>Social Security Card:</b> The Social Security Card is requested for all students. Parents may elect to sign a waiver if they prefer not to give the social security number.</p>	
<b>Document #7</b>  <input type="checkbox"/>	<p><b>Age Verification:</b> One of the following documents is required to confirm your child's age:</p> <ul style="list-style-type: none"> <li>A. A certified copy of a birth certificate,</li> <li>B. A certified hospital issued birth record or birth certificate;</li> <li>C. A military ID;</li> <li>D. A valid driver's license; A passport;</li> <li>E. An adoption record;</li> <li>F. A religious record signed by an authorized religious official;</li> <li>G. An official school transcript</li> </ul>
